General description	<p>Public planning of Tourism Development is a basic matter that gives in the second semester of the third course of the Degree in Tourism. Practices through ICT	Activities of application of the knowledges to concrete situations, and of acquisition of basic skills related with the matter object of study, developed in classrooms of computing.
Presentation	Exhibition by part of the students in front of the educational and/or a group of students of a subject on contents of the matter or of the results of a work, exercise, project... Can carry out of individual way or in group.
Seminars	You interview that the student is supported by the lecturers of the matter for advice/develop of activities of the matter and of the process of learning.

Other comments on the Evaluation

Two possibilities of evaluation:

A) The evaluation of the matter will be continuous. 50% of the note will configure from examinations type test on the contents of the matter, the 20 % of the note will base in the resolution of exercises, practical, problems and analysis of case, and the 30 % will be the note of a project in group, of compulsory delivery and exhibition. To surpass the matter by continuous evaluation is precise to have presented to all the proofs, deliver all the practices required and make and present the project in group. Or students that surpass the matter by means of continuous evaluation will not require to present to final examination of the matter.

B) When it do not proceed the continuous evaluation (by that the student like this have decided it or by have not surpassed the continuous evaluation) will make a final examination, that will suppose 100% of the note. The examination will consist of a theoretical part (short questions and/or type test) (60% of the final note) and a practical part (40%). The students that surpass the matter by continuous evaluation but wish to go up note will be able to present to the final examination. In this case, the note of the final examination will substitute to the note of the continuous evaluation to all the effects.

The corresponding examination to the second and back announcements will follow the same model that the final examination. The students that do not present the continuous evaluation neither the final examination, will appear in the records as no presented. The students that do not surpass the continuous evaluation and do not present to the final examination, will appear in the records like suspenses.

Dates and schedules of the proofs of evaluation of the different announcements will be the specified in the calendar of proofs of evaluation approved by the Xunta de Centro for the course 2020-21. In case of conflict or disparity between dates of the examinations, will prevail the distinguished in the web page of FCETOU.

Attention to students will happen to be made by telematic means (email, virtual dispatch, conversation in fatic, etc.) and will be previously concerted by email with the teacher/lecturer, to facilitate contact in forecast of problems of conciliation and/or connectivity.

* Additional bibliography to facilitate to car-learning

The teacher will put the disposal of the students, through the platform fatic, the bibliography or necessary materials for the reinforcement of the education, in case to happen to a no face-to-face modality. This bibliography will be specific for each subject and epigraph. The general bibliography will be the same that the specified for the face-to-face education.

The quantity and typology of the educational material (audiovisual or writing) will be the necessary to guarantee that the students do not lose any type of content, practical or competency.

=== ADAPTATION OF The EVALUATION ===

To evaluation was designed not to have to be modified in a stage of no face-to-face methodology, giving a greater weight to the autonomous work of the students.

The billed of the tasks, as well as the available materials will be adapted to the new situation of work no face-to-face in remote and will be put the disposal of the students with the sufficient time respect of the deadline of delivery.

The proofs will happen to make through Virtual Campus/Faitic or through an oral exam in case of problems of connectivity by part of the students.
