It is part of the subject called: Methods, models and techniques of Social Work. Its main objective is that students approach the professional intervention of Social Work, knowing and analyzing its concept both classically and from a critical perspective. In order to operate in a scientific way in the profession of Social Work, it is essential that students know, handle and analyze the different theoretical and methodological perspectives of the discipline to ensure an adequate intervention. Without forgetting that any perspective used must be in line with respect for Human Rights.

C5	To interact with persons, families, groups, organizations and communities in order to bring about changes, promote development and improve their conditions of life through the use of the methods and models of Social Work, monitoring regularly the changes that are taking place with the aim of preparing the completion of the intervention.

- C6 To prepare, produce, implement and assess the plans of intervention with the client system and the professional colleagues, to negotiate the supply of services that must be used and review the efficiency of the plans of intervention with the people involved in order to adapt them to changing needs and circumstances. All this, taking into consideration the ethical obligations of the profession concerning trust, proximity, friendliness, equal relations, respect for cultural diversity, etc.
- C7 To contribute to the establishment of networks to deal with the needs and work towards the achievement of the programmed results, examining them with the people involved and the support networks they might have or develop; particularly, in the case of women (abused women, regular caregivers of people with disabilities, people with mental and other disabilities[]), taking into consideration the specific characteristics of Galicia as a country with a geographically dispersed population, a marked contrast between rural and urban spaces, numerous abandoned areas and an ageing population (which requires larger networks).
- C8 Promote growth, development and independence of persons by identifying opportunities to establish and create groups, using programming and group dynamics for individual growth and strengthening of interpersonal relationship skills; in particular, with multicultural diversity groups (immigration, return emigration, ethnic minorities...) and with women, taking into account their historic marginalisation in relation to sociocultural participation and in decision-making bodies (empowerment).
- C9 To work on types of behavior that imply a risk for the client system through the identification and assessment of the situations and circumstances that determine such behavior and the implementation of strategies to change them.

Other comments on the Evaluation

In order to pass the subject, each of the tests foreseen in the evaluation section must be passed previously and independently. In any case, the student will not be evaluated if he/she does not present in time and form the tasks assigned for the seminars and the tutored work.

Students are warned that no grade will be kept for the following year, this aspect applies to both students in attendance and non-attendance.

EVALUATION SYSTEMS

ATTENDANCE STUDENTS: students will be considered as such if they have a minimum attendance of 80% in the lectures and a maximum of two absences in the seminars (either face-to-face or virtual). If this requirement is not met, the student will be evaluated as a non-attending student. The modalities, as well as, the punctuation is the one established in the evaluation methodologies.

Remember that it will only be possible to pass the subject when a pass is obtained in each of the methodologies independently.

NON-ATTENDANCE STUDENTS: those students who do not meet the minimum requirements of attendance to classes (lectures and seminars, both in person and, if applicable, virtual). This student will be evaluated in a global and unique final test that will consist of (each of the parts must be approved independently in order to pass the course and all passed,

otherwise they will return to the unique test in the second convocatoria):

a.-Final exam in the official call by means of objective test (same format and correction system as for the assistants). This exam will deal with the theoretical contents of the lectures and seminars. It will score 40%.

b.-Delivery of a dossier that collects the work done by the assisting students for the tasks of the seminars and the contents related to the tutored work (prior to its delivery it must be supervised throughout the course, with obligatory character, by the teacher). The student must also present (in this dossier) the conceptual maps of the theory to be examined and two pages of conclusions for each theory that is not the object of the development question. It will score 20%. It will only be evaluated if the student passes the multiple-choice exam.

c.-Development question: it will only be evaluated if the student passes the multiple-choice exam, it will deal with the aspects and materials related to the tutored work, it will be evaluated as long as the first part of the multiple-choice exam has been passed (it will evaluate the competences obtained by the students in the tutored work). The student will select the theory to be developed and it will be included in the dossier. It will score 10%.

d.- Written defense with short reflection questions on the official exam date, if it is possible due to teaching organization, it will be done orally on the date and time indicated by the teacher. It will score 30%.

WARNING: The continuous monitoring of classroom activities and communication with students related to the tasks will be done through the Moovi Platform.

FOR ASSISTANT AND NON ASSISTANT STUDENTS: at the beginning of the course, documents with the instructions and the schedule for the delivery of the assignments and evaluation tests will be uploaded, being compulsory to pass the course.

Students will be required to know how to write correctly and without spelling mistakes (including graphic accents and abbreviations), how to read comprehensively, analyze and synthesize as well as summarize what they have read or heard in the classroom. It is also expected that he/she knows how to express him/herself correctly and in accordance with the level required by a university cycle, using terminology suitable for this linguistic register. All this will be part of the student's evaluation and, in any case, will have to be reflected in their exercises and in the exam. Plagiarism means immediate failure of the subject.

- 1.-To work and study in a continuous way to advance notably the overcoming of the subject, since it is a subject that requires to settle the contents in a continuous way.
- 2.-To read the topics of the lecture session prior to it, in order to improve the understanding of the general explanation of the teacher, as well as to bring elaborated the doubts to the classroom to be able to solve them according to the needs of the students.
- 3.-To carry out the activities planned for each seminar on the day of the seminar.
