## Competencies

Methodologies	
	Description
Introductory activities	This session is aimed at getting in touch with students and obtaining information from them, as well as at introducing the course (aims, contents and assessment process).
Lecturing	The theoretical content of the units outlined above will be presented in this type of session.
Laboratory practical	Lab sessions are intended as training in English pronunciation (from the perspective of both auditory discrimination and oral production) and in phonological or broad transcription.

Problem solving	These sessions will be devoted to practical phonology exercises and/or autonomous or small-group activities based on the theoretical contents previously introduced in lectures.
Seminars	These tutorials will provide general guidance aimed at solving exercises/activities, revising concepts, solving doubts, explaining methodological issues, etc., that is, counselling on course activities and contents as well as on the learning process.
Autonomous practices	Autonomous online practice consisting in exercise/problem-solving or other practical activities
through ICT	based on the theoretical contents.

# Other comments on the Evaluation

# A) FIRST EDITION OF RECORDS (ACTAS) IN DECEMBER/JANUARY

# a) Continuous assessment

Students will be assessed at the end of the first term on the basis of their continuous performance throughout the course.

The continuous assessment system will comprise the following obligatory parameters (figures in brackets indicate the percentages of the final mark):

- (1) Active participation in class (10%). Though class attendance is not compulsory, regular attendance will be positively valued.
- (2) Two tests which will take place the week immediately after the end of unit 4: one test on the theoretical contents, exercise or problem-solving related to the first 4 units of the syllabus and a phonological transcription (10%), and a second test on the lab activities of auditory discrimination and oral production (5%). <u>Note</u>: In case of a fail or non attendance, there is no possibility to retake the tests. The percentages of the final mark achieved are summative. The dates of these tests will be announced in class and through the Faitic platform in advance.
- (3) Submission of specific assignments (exercises, transcriptions, recordings, etc.), which will be asked to be done either in the classroom or as homework, with or without prior notice, and degree of performance of autonomous online activities (15%). Note: Failure to submit an assignment within the timespan assigned and in the format requested will count as a zero. In case of failing any activity, there is no possibility to compensate the mark by another one, unless the lecturer informs otherwise. The percentage of the final mark achieved is summative.
- (4) Final exam (60%): It will consist of two components, a theoretical-practical one and a lab part (auditory discrimination and oral production), which will constitute 65% and 35% of the final exam mark, respectively. They will cover all the theoretical and practical contents presented throughout the term, including obligatory reading assignments from both the coursebook and supplementary sources. In order to pass the course it is compulsory for students to pass each of the two exam components (theory and practice) with at least 4/10. Students not satisfying this requirement will not pass the course even if the average mark of the four parameters is 5/10 or above. The theoretical-practical part of the final exam will be held on the day and hour and in the room indicated in the exam calendar approved by the Faculty Board. The date, hour and room of the lab part of the exam will be announced in class and through this platform in due course.

## b) Exam-only assessment

Students unable to comply with the requirements of the continuous assessment system due to duly justified reasons will have to inform the teacher <u>during the first 15 days of the course</u>. These students will be assessed on the basis of a single final exam which will constitute the entire final mark (100%). The exam will cover all the contents introduced throughout the first term, including obligatory reading assignments from both the coursebook and supplementary sources. The exam will consist of two components, a theoretical-practical one and a lab part (auditory discrimination and oral production), which will constitute 65% and 35% of the final exam mark, respectively. In order to pass the course it is compulsory for students to pass each of the two exam components with at least 4/10. Students not satisfying this requirement will not pass the course even if the average mark of the two components is 5/10 or above. The final exam (both the theoretical-practical and the lab component) will be held on the same date, at the same time and in the same room as for students following the continuous assessment.

Students are strongly recommended to attend classes whenever they can.

# (B) SECOND EDITION OF RECORDS (ACTAS) IN JUNE/JULY

Students not passing the continuous assessment on the first edition of records, or students not passing the exam-only assessment after opting for this type of assessment at the beginning of the term, will be assessed anew in June/July for the second edition of records. This assessment will be based on a single final exam which will constitute the entire final mark (see section (b) above on exam-only assessment). Should the student have passed one of the two exam parts (the theoretical-practical or the lab part) with at least a 5/10 in the December/January sitting, that mark will be used to recalculate the final course grade in June/July and the student will only have to retake the part that was failed in the first sitting.

The theoretical-practical part of the exam will be held on the date, at the time and in the room indicated in the exam calendar approved by the Faculty Board. The date, hour and room for the lab component of the exam will be announced through the Faitic platform in advance.

Note for all students regardless of the type of assessment:

- Linguistic correctness will also determine the mark obtained.
- Any instance of plagiarism in any activity, test or exam will derive in failing the relevant activity, test or exam. Claiming ignorance of plagiarism will not exempt the student from liability.

#### Other comments

To make the most of the lectures, students are advised to have done the mandatory readings before each session. This will allow them to understand better the contents that will be explained and to give them the chance to raise doubts or make relevant comments.

In order to do the exercises or other practical activities, it is compulsory to have done the mandatory readings as well as to review the notes taken in the lecture sessions.

In order to both follow the lectures and do the practical activities, students are advised to do the readings from supplementary bibliographical sources apart from the relevant readings from the textbook. All supplementary sources are available in the library.

It is the student is responsibility to regularly check the materials and updates on the Faitic platform and to be informed about assessment dates.

Desirable previous competences:

- Good knowledge of the English language (B2 level or above).
- Use of the different resources offered by the library.
- Basic skills in handling computer tools and the Internet.

In order to achieve these competences, students are advised to attend special training sessions.

Not only the relevance and quality of the responses will be considered for assessment but also linguistic correction.

Total or partial copy or plagiarism of any type of activity or exam will be penalized with a zero on that activity or exam. Claiming ignorance of plagiarism will not exempt the student from liability.

During classroom sessions students are not be allowed to use mobile devices (iPhone, tablet, PDA or similar) or computers, unless the teacher requests their use for pedagogical reasons.

Students must observe copyright laws with regard to books as well as to original materials designed by the teacher and provided to students in class or via the Faitic platform.

Exchange students interested in taking the course are advised to have an English language competence equivalent to at least a B2 level according the CEFR for languages.

The study of suprasegmentals initiated in this course continues in the 4th-year course "Discurso oral do primeiro idioma estranxeiro: Inglés (V01G180V01901) with the study of the intonation systems, among other contents.
